ORDER

As per U.O. read as (5) above, the regulation relating to registration for and award of Ph.D, a pre-submission Seminar conducted in the Department/ Research Centre is one of the requirements for submission of thesis. Research Scholars who have passed the Course work Examination and in the final stages of research are eligible to apply for the pre-submission presentation.

Sanction has been accorded by the Vice-Chancellor to Smt. Daisy Samuel, a full-time Research Scholar in Commerce, being permitted to conduct her pre-submission seminar at the Department of Commerce.

The following guidelines are to be observed while making the pre-submission presentation:

1. The pre-submission seminar will be organised in the Department concerned and will be conducted by the Department, Doctoral Committee and the external expert nominated by the Vice-Chancellor.
2. The pre-submission presentation will be open to all Faculty Members/ approved guides and research students of the discipline.
3. The Chairman of the Doctoral Committee shall be the Chairman of the pre-submission presentation Board and guide shall be the Convenor. It shall be the responsibility of the Convenor to intimate all the Faculty Members/approved guides and research students of the discipline about the programme.
4. The presentation should not exceed 30 minutes and may discuss the various aspects of the thesis. While the student can refrain from disclosing the results, it is the duty of the student to establish that the research work satisfies the requirement for the Ph.D.
5. Recommendation of the Board has to be included in the thesis as per the advice of the guide.
6. If the candidate fails to turn up for the presentation due to unforeseen exigencies, a new date can be requested on recommendation of the Board.
