**O R D E R**

The University Audit Wing, Karyavattom Campus had sought that the HRA rates to Research Scholars admissible as per University Rates be clarified.

However, Joint Registrar, Campus Administration, Karyavattom vide letter read as paper (2) above had informed that the University Order has not taken into account the period 21<sup>st</sup> May, 2009 to 31<sup>st</sup> October, 2010. The rates thereafter have been reported by the Finance vide reports referred (3) above on requisition.

Sanction has therefore been accorded by the Vice-Chancellor to the University HRA rates admissible with effect from 01/03/1992 as specified below:

` 50/-	with effect from 01/03/1992
` 100/-	with effect from 01/11/1998
` 150/-	with effect from 01/03/2006
` 600/-	with effect from 01/11/2010
` 840/-	with effect from 01/02/2011

The rates will be applicable in general to all UGC Scheme Fellowship/Scholarship pertaining to claim of HRA as per University rates. The above rates are the same as specified in Government Pay Revision Orders of 2004 and 2011.
